

Dear Camp Parents,

We are happy to offer you our free, roundtrip nonstop bus service from Greene (formerly Jordan) Middle School to our campsite in Mountain View. The bus we'll use is a Highway Patrol certified and regularly maintained large yellow school bus. We have chartered it from Cupertino Union School District and that name is printed on the side of the bus in black letters. As with all large school busses, there are no seat belts. Look for a "Decathlon Sports Club" sign in the window. There is a licensed bus driver and a camp representative on the bus who will be wearing a camp t-shirt and will have your child's name and registration form in a notebook.

We already have all your contact and emergency information on file, so there's little more we need from you except to have you fill out and mail in the attached registration form.

If you think you might use the bus service even once during the summer, please complete, sign the attached registration form and return it (mail, email, or fax 650-941-2848). The registration form is due back to us by June 1st, you may want to send it in with your final camp payment (May 1st or June 1st).

## **BUS SERVICE BASICS** (please keep for reference)

### **PICKUP/DROP-OFF LOCATION:**

Greene Middle School  
750 North California Ave.  
Palo Alto, CA 94303  
(Please meet the bus at the  
front entrance to the school.)

### **AM PICKUP 8:40 AM:**

The camp bus will arrive each morning at 8:40 am. Campers will be loaded, roll taken, & then off to camp at 8:45 am. (We are unable to wait for any late campers to arrive.)

### **PM DROP-OFF 4:05 PM:**

In the afternoon the bus will arrive back at Greene at 4:05 pm.

### **IMPORTANT AFTERNOON SAFETY POLICY:**

To ensure the safety of your child/children, our camp policy dictates that if you (or the person who usually picks up your child/children) are not at Greene (formerly Jordan) Middle School when the bus arrives at the end of the camp day, the bus driver will keep your child/children on the bus, wait approximately 5 minutes (until 4:10 pm.) and then take him/her/them back to Springer School (1120 Rose Ave. Mountain View 94040). Your child/children would then join our "Extended Care" program in the Multi at Springer School until you arrive. There will be a charge of \$10.00 per hour for that supervision. If you wish to give the camp permission to drop off your child/children at Greene (formerly Jordan) Middle School and leave him/her/them unattended at Greene (formerly Jordan) Middle School, you may do so only by checking the appropriate box and signing on the enclosed registration form.
